- She/he also supports due diligences in other S4G geographies, when required
- She/he leads the production of analysis and argumentation to inform investment decisions, and develop his own recommendations
- She / he co-develops with entrepreneurs their impact plan, a mirror of the business plan outlining the impact of the startup on the environment
- She/he co-leads the set-up of best-in-class venture capital tools and processes
- She/he prepares the support document for Investment Committee decision on potential investments
- She/he participates in interfacing with the stakeholders involved in due diligences to capture the relevant operational insights and build robust recommendations
- She/he is also in relationship with other VC/CVC funds investing in similar themes
- She/he is involved in managing corporate interactions to introduce startups to partners and to collect qualified insights from experts on startups
- She/he analyzes the fund performance and contributes to assessing the investment portfolio value
